2024 Mill Rates

For 2024, Council is once again happy to say that they have opted to keep the municipality's mill rate and mill rate factors (MRF) the same as the last few years values. The school mill rates have also stayed the same for 2024. Municipal and Education mill rates are listed below:

Development Permits & the Building Bylaw

All ratepayers **must** contact the office for a Development Permit Application for **any/all** development(s) on their property. Development must not proceed until the Administrator has issued a letter stating the development has been approved by Council. The reason for the issuance of an approval letter is to ensure that all development meets the Zoning Bylaw requirements and, most importantly, that you have not developed on a road allowance, too close to the road or property line or on environmentally sensitive land. There is no charge for this.

Any new construction or structural altercation to houses/residences will require a Building Permit and have to be inspected by a Licensed Building Official (Building Inspector). The only buildings exempt from this are farm buildings that DO NOT have sleeping quarters (shops, barns, bins esc. used only for agricultural purposes). ANY building with sleeping quarters or used for commercial purposes will require a Building Permit and are subject to a building inspection. There are fees associated with building permits. For more information or if you have any questions, call the office.

Controlled Burns

Do not forget to report <u>ALL</u> controlled burns, please call the Provincial control burn line at <u>1-866-404-4911</u> to avoid being charged for an unnecessary fire response. Ensure to call back when the control burn is complete.

Cost of Well Key

The price for a well key is \$125.00 yearly. The cost of having a well key is invoiced yearly and sent with your tax notices. If you are interested in using one of our public water wells, please contact the office to receive a key.

2024 Municipal Elections

This year positions for Reeve, and Division 1 & 3 Councillor are up for election. Please watch the Weyburn Review and Weyburn This Week for information regarding nominations, notice of poll, etc. If an election is necessary, all ratepayers of the municipality will be able to vote (if eligible) for Reeve and only those ratepayers registered in Polling Division 1 or 3 will be required to vote for a respective Councillor. Ensure to check your Polling Division which is stated in the top left corner of your Tax Notice. Government issued ID is required when voting just like provincial and federal elections.

Primary Weight Permits

Primary weight permits are available for purchase at the Administration Office for an annual fee of \$100.00/unit. All municipal roads in the municipality are secondary weight roads, unless indicated otherwise and except for the Clearing The Path (CTP) roads (also known as the Correction Line and Pool Road). Purchasing a permit allows ratepayers to haul loads over the secondary weight limit, unless indicated otherwise, on all municipal roads legally within the municipality.

Information Updates

If you have a new address or phone number, please get in touch with the office so we can update our ratepayer contact information. If you are interested in receiving email updates from the RM, send us an email at rm97@sasktel.net to be added to our ratepayer distribution list.

We would like to be able to send emails to our ratepayers advising them when certain restrictions are put in place or removed, i.e., Winter Weights, Spring Road Bans, Fire Bans etc. or when important information needs to get out to ratepayers quickly. This type of information will also be posted on the RM's website. Please know that the number of emails sent will not be overwhelming and email addresses will never be shared with the general public.

Payment of Taxes and Other Amounts Owning

Taxes and other amounts payable to the RM of Wellington No. 97 can be paid by cash, cheque, or online either by e-transfer or as a vendor payment through your banking institution. Debit and credit card payments are not accepted. Please check with your banking institution to see if the RM is set-up as a vendor. Start your online banking vendor payment search with **RM OF WELLINGTON** or **WELLINGTON NO** when searching for the RM's vendor name (we are not set-up as a vendor with RBC or CIBC). Your account number for online banking must be a total of 4 digits. It is listed in the top right-hand corner of your tax notice. If your account number is shorter than 4 digits, use zeros to prefix your account number - for example your account number is CAD, you will enter 0CAD as your account number. If your banking institution doesn't have the RM set up as a vendor, an e-transfer can be sent to mm97@sasktel.net. These transfers are automatically deposited into the RM's bank account.

Saskatchewan Lotteries Trust Fund for Sport, Culture & Recreation

Each year the RM receives a community grant to be given to local non-profit volunteer community groups that get people involved in sport, culture and recreation activities. The 2024 grant was split equally 3 ways between groups that are used in some way by Wellington ratepayers. The recipients were the West Osage Gun & Archery Club, the Francis Skating & Curling Rink and the Fillmore Recreation Centre. The deadline for community groups to apply to the RM for a portion of this grant is **May 31, 2025** for activities that will be administered from April 1, 2025 to March 31, 2026. If you would like to receive more information regarding program criteria, please feel free to contact the office.

Gopher Control

The RM brought in Burrow Oat Bait, a new product that has comparable results to strychnine. Burrow Oat Bait's active ingredient is Zinc phosphide 2%, a powerful acute rodenticide. It comes in 20kg bags and can be purchased at the RM office for \$99.50. We also have 9kg pails of Rozol for purchase. The cost of a pail is \$119.00 plus pst.

Things To Be Mindful Of:

The RM's right of way on most roads in the municipality is 66' or 20m (33'or 10m from the centre of the road on each side). Please keep this in mind when spraying or farming your land which is next to a main municipal road. Having the grass killed off by over spraying in the right of way or farming into the right of way jeopardizes the strength of the road and promotes the growth of weeds.

Please abide by the posted speed limits while moving within the RM. Also remember to slow down for oncoming traffic to avoid damage from rocks.

Custom Work

The RM offers custom work to our ratepayer at the below costs. If this is something you are interested in call the office or check the website for our application form. Note that custom work will not be prioritized and will be done when operators have time.
